

NETSTRATA JUBILEE STADIUM – CONDITIONS OF ENTRY

The following Conditions of Entry will apply to all patrons attending Netstrata Jubilee Stadium. These conditions should be read in conjunction with the conditions of sale appearing on each ticket, which may vary from the Venue's Conditions of Entry from time to time.

Please note that these Conditions of Entry may vary between events.

Management, authorised staff and their contracted representatives have the following rights to refuse entry, search, remove patrons, remove and confiscate any other item deemed to be a potential risk to the comfort and wellbeing of patrons attending the Venue.

Refusal of Entry

For the comfort, safety and enjoyment of all patrons, Netstrata Jubilee Stadium management reserves the right to refuse entry:

- To any person deemed to be intoxicated and/or disorderly
- To any person that does not have a valid form of entry or who is unauthorised for access
- Of items which have the potential to cause injury or public nuisance (i.e. large flags/banners, musical instruments etc.)

General conditions

- Entry to the Venue is subject to the holding of a valid ticket or pass
- Persons entering Netstrata Jubilee Stadium will be subject to security checks, including the inspection/search of any bags and packages brought into the Venue, regardless of size; wand and pat-down searches. Any person refusing to undergo such security processes will be refused entry to the Venue
- All patrons consent to monitoring by closed circuit television
- For the safety of patrons, leaning on, sitting on or climbing over handrails/balustrades/fences, as well as standing on seats is strictly prohibited
- Seats retract automatically. To avoid potential damage or injury, patrons must check their seat is properly and safely positioned before taking their seat
- Storage or placement of any items or equipment in stairwells or walkways is strictly prohibited
- Persons gaining unauthorised access to the Venue and/or the Venue's playing arena will be removed from the Venue and may be liable for prosecution
- Any person arrested or detained by NSW Police or evicted from the Venue may be excluded from attending events at the Stadium for a minimum of 12 months.
- Patrons who cause a disturbance, or refuse to comply with reasonable requests made by staff will be removed from Netstrata Jubilee Stadium

- Refusal to comply with a reasonable authorised request or to leave an area of the Venue may result in prosecution
- If patrons contravene any Conditions of Entry, they may have their ticket confiscated and or cancelled without refund or recompense
- The use of cameras/mobile phones/recording devices is prohibited in all dressing rooms and toilets
- It is a condition of entry to Netstrata Jubilee Stadium that a person does not attempt to conceal their identity, either at the point of entry or while inside the Venue. While Netstrata Jubilee Stadium will respect cultural differences or medical conditions, it reserves the right to either refuse entry, or to remove anyone who covers their face with a scarf, balaclava, mask, hat or helmet etc.
- Any person who attempts entry or is found to have entered the Venue after being issued with a current Banning Notice will be subject to prosecution and possible further penalties
- Pass outs are available at all operating gates. Patrons are required to scan their valid ticket out and back in for re-entry, through the gate marked on the ticket
- Commercial food products cannot be taken into or from the Venue by patrons. Homemade foods/package snack foods (lollies/chips)/baby food are permitted into the Venue. Drinks must be sealed/unopened
- Netstrata Jubilee Stadium is a non-smoking Venue, including e-cigarettes. Smoking is not permitted within 4 meters of any entry point. Patrons wishing to smoke must utilize a pass out at the gates
- Patrons wishing to bring personal items into the Venue do so at their own risk. Management will not be held responsible for any damages to loss or theft of a patron's personal property
- Umbrellas may be brought into the Venue however cannot be opened in the seating bowl. The use of umbrellas within the Venue should take into account patron comfort. Please note umbrellas are considered a prohibited item for Asian Champions League events
- Patrons are to respect all others and not engage in any conduct act towards or speak to any player, match official or any other patron in a manner which offends, insults, humiliates, intimidates, threatens, disparages and vilifies that person on the basis of that person's race, colour, region, decent, nationality or ethnic background
- Prams and strollers are not permitted into seating areas and cannot be kept in aisles or other open areas which may impact the safe passage of patrons. Prams and strollers must be stowed under seats in such a manner that they do not create a trip hazard to patrons moving between seats. Prams left inside gates by patrons are not monitored by staff.
- Folding chairs are permitted into the general admission hill areas only. The general admission hill areas may be enforced as a "Standing Area Only" when capacity is reached, at which time chairs of any kind will not be permitted
- Unauthorised soliciting and customer surveying is not permitted
- Patrons are not permitted to throw any objects around or within Netstrata Jubilee Stadium seating areas
- Some sporting and other activities are dangerous. Patrons viewing such activities do so at their own risk

- Patrons should note that children (under the age of 12 years) must be supervised by an accompanying adult or guardian (over the age of 16 years) at all times while in the Venue
- Patrons should take appropriate care for their sun protection and hydration
- Netstrata Jubilee Stadium, may from time to time, take photos for publication or promotional purposes

Prohibited items

The following items are not permitted into Netstrata Jubilee Stadium:

- Alcoholic beverages
- Illicit drugs/illegal substances
- Glass bottles or breakable containers
- Unsealed beverages of any kind
- Metal containers and cans
- Flares, fireworks or any other explosive device
- Laser pointers
- Balls or other missiles (including inflatable items, frisbees, tennis balls and cricket balls)
- Whistles, hooters and horns drums and significant noise-making instruments
- Knives or other dangerous weapons, including toy/imitation weapons
- Professional (long lens) cameras and recording devices for commercial purposes, including any lenses over 200mm
- Poles (including metal flag poles), sticks or oversized flags/banners (1.5m x 1m with flagpoles over 1.5m), including “selfie sticks”. Specific conditions may apply for some events regarding the entry of flagpoles, flags and banners. All flags and banners must be pre-registered
- Confetti, shredded paper or register rolls
- Scooters, roller skates, skateboards and push bikes
- Animals, including dogs and other pets; excluding guide dogs or other assistance animals
- Patrons are not to wear or otherwise display commercial, political or other offensive signage or logos
- Eskies and bags of larger dimensions than 30cm L x 20cm W x 35cm H
- Cans of spray paint and marking pens
- Other items as determined by the Venue management, which may cause injury or present a public nuisance to any user of the Venue

Liquor licensing

Netstrata Jubilee Stadium practices the responsible service of alcohol. All persons entering Netstrata Jubilee Stadium are advised that:

- They are entering a licensed premises
- Intoxicated persons will not be permitted to enter
- Persons in possession of liquor will not be permitted to enter
- Alcoholic beverages must not be removed from the Venue
- Checking procedures will apply to prevent persons possessing liquor from entering
- Intoxicated persons will be removed from the Venue
- It is an offence for minors to purchase and consume liquor and it is an offence to purchase liquor for (or supply liquor to) minors or persons who are intoxicated
- Persons supplying liquor to minors will be reported to the Police and penalties apply under the Liquor Act 2007

COVID-19 SPECIAL CONDITIONS OF ENTRY

Venue entry conditions

Each patron entering Netstrata Jubilee Stadium agrees and accepts that they must adhere to the current NSW Health Order in relation to COVID-19 which will change from time to time.

All persons entering Netstrata Jubilee Stadium are advised to adhere to these additional venue restrictions:

- Please stay home if you have been to any of the venues listed on the NSW Health website (www.nsw.gov.au/covid-19/latest-news-and-updates)
- Head straight to your specified section and row – try not to linger, and move to the side if you need to stop
- Follow signage and directions of all Venue, Security and Customer Service staff, as well as Club Officials. They are there to keep you safe
- Only sit in the allocated seated area shown on your ticket
- If you have purchased tickets for others, you are the responsible contact for contract tracing. You must be able to provide a name and contact number for every person in your group should NSW Health make contact for contact tracing
- All patrons ticketed to the Eastern and Southern Hills sections may not be permitted to stand during the event and will be asked to be seated on the hills
- In the event of wet weather, you will need to remain in your allocated seat or area – seat changes cannot be accommodated
- Avoid unnecessary contact i.e. shaking hands, hugging, etc.
- Maintain a physical distance of at least 1.5m from people outside of your immediate group when moving around the Venue
- Practice good hand hygiene using the sanitiser stations located around the Venue
- Stay home if you are feeling unwell, are showing symptoms of COVID-19 or have been in contact with someone who has felt unwell in the past 2 weeks
- Cough/sneeze into your elbow
- Tickets can be purchased by EFT only from the onsite Box Office
- Food and beverages and tickets can be purchased via cashless payment methods only
- Random temperature checks may take place upon entry and must record below 37.5C to permit entry
- Immediately notify a stadium contact if they begin to feel ill, or are developing COVID-19 symptoms (including fever, cough, sore/scratchy throat, shortness of breath, loss of smell/taste, runny nose, muscle pain, nausea/vomiting, diarrhoea) whilst on site (note: if a person is suffering from or displaying any of these symptoms, the Stadium reserves the right to refuse entry to or exclude that person from the venue)

Netstrata Jubilee Stadium Conditions of Entry

- Abide by public health order at the time which may require patrons to wear a face mask while attending the event, or remain seated while eating and/or drinking

In accordance with the Government health requirements in the response to the COVID-19 pandemic, all persons entering Netstrata Jubilee Stadium will be subject to the following (depending on the current status of the government health requirements which will change from time to time):

- The requirement for each person to provide a name, mobile phone number and email address to be used for COVID-19 tracing and follow up purposes only;
- The requirement to provide a declaration regarding certain matters relating to COVID-19; and
- Each patron may be required to digitally check in via a QR code system, from time to time.

Further to the above, all working personnel entering the Venue will be subject to the following:

- The requirement for each person to provide a name, mobile phone number and email address to be used for COVID-19 tracking and follow up purposes only;
- The requirement to provide a declaration regarding certain matters relating to COVID-19; and
- Each member of staff is required to digitally check in via a QR code system
- From time to time, the requirement to complete a Health Screening process which may include a temperature check. Should a person's temperature be recorded to be above 37.5 degrees Celsius, then the Venue reserves the right to refuse the person entry to the Venue.

Any person coming to the Venue either in a working capacity or in possession of an event ticket **MUST NOT** attend:

- if they have been in contact with someone with COVID-19, or currently awaiting COVID-19 test results;
- if they are feeling unwell;
- if they have been in contact with a suspected or confirmed COVID-19 case in the past 14 days;
- if they have returned from overseas in the past 14 days; or
- if they have attended one of the following locations during the dates detailed by the NSW Government website (www.health.nsw.gov.au/Infectious/covid-19/Pages/case-locations-and-alerts.aspx).

Health and safety conditions

- You acknowledge that, despite the current control and capacity measures currently in place, there remains an unquantifiable risk of transmission of a viral illness including COVID-19 at any event
- By proceeding with the purchase of your ticket/s to the event, you have considered your own personal circumstances including any health conditions which may increase your risk of contracting COVID-19, and you have assessed the potential health risk to you and any persons who attend the event with you

- By agreeing to purchase this ticket, you accept any liability and inherent risk related to COVID-19 and you acknowledge that COVID-19 can have serious health consequences. By attending this event you (and any persons who attend the event with you) acknowledge and accept these risks
